1. ACKNOWLEDGMENT OF INHERENT RISK

I understand that participation in skating, figure skating, and any other sporting activities listed in the enclosed appendix (hereinafter the "Sports Activity") is voluntary, and involves inherent risk during participation, including the risk of possible accidents, physical injury, or exposure to the COVID-19 virus or other infections or infectious diseases as a result of attending training, club events or competitive events. I freely accept and fully assume all such risks, dangers and hazards, including but not limited to personal injury, disease transmission, death, property damage or loss, resulting from my participation. I have carefully considered the risks involved, and I have full confidence that reasonable precautions will be taken to ensure the safety and well-being of myself (or my son/daughter/ward).

2. WAIVER

I do for myself (or my child), and our respective heirs, executors, administrators, successors and assigns, hereby waive, release, and forever discharge Skate Canada and/or [Skate Canada BC/YK Section], [all Regions of Skate Canada BC/YK Section], Abbotsford Skating Club, their officers, partners, agents, employees, servants, representatives, volunteers, coaches, officials, successors and assigns (the "Representatives") of and from any actions, causes of action, complaints, demands and claims or any recourse whatsoever ("Claims") that I have or may have in the future in any way connected with my (or my child's) participation in the Sports Activity contemplated herein, whether in law or in equity, in respect of personal injury, illness or disease transmission, loss of life, or property damage of any kind or nature, and I do hereby discharge the Representatives from any such liability. The Abbotsford Skating Club will be offering the following activities between the dates of September 1 2021- August 31, 2022.

Private and group lesson sessions, length in time varies between each session.

Private sessions will be designated as Senior/Intermediate 2, Senior/Intermediate 1 & Intermediate 2, Junior/Intermediate 1 or Open. Group lessons are designated as Jr CanSkate, CanSkate, Skate Academy, Star Academy and Adult Skate. On ice lesson sessions will be held at MRC Arena located in Abbotsford, BC

Off-Ice classes are prior to or shortly after at the completion of the skater's on-ice session. Off-Ice classes will be held in the aerobics room, senior center or community room at MRC Arena. There will be a maximum of three 30 minute classes a day. Participants will attend only the class/es designated to their on ice session/s.
